Award of Contract for BHP Billiton's Olympic Dam Operations in South Australia and extension of Chevron contract until 2021

BHP Billiton – Olympic Dam

The Company is pleased to announce it has been awarded a 5 year contract with BHP Billiton for the Olympic Dam operation.

Located 560 kilometres north of Adelaide, South Australia, Olympic Dam is Australia's largest underground mine, producing copper cathode, uranium oxide concentrate, gold and silver. Toxfree will provide both industrial services and waste management services to BHP Billiton for the Olympic Dam site. The 5 year contract will commence in June 2016.

The contract scope includes management of all wastes generated from mining operations, industrial cleaning and quarantine services, landfill management and recycling services.
